Brief Description of the concession

PT Sumatera Riang Lestari Blok II Garingging obtained a Decree of the Minister of Environment and Forestry no. Minister of Environment and Forestry Decree No. SK.984/Menlhk /Setjen/PLA.2/2019 dated 11 November 2019 concerning the determination of the work area of 42,521.15 Ha. Then, PT Sumatera Riang Lestari Blok II Garingging obtained a business license for forest utilization based on the Decree of the Minister of Environment and Forestry of the Republic of Indonesia SK.645/MENLHK/SETJEN/HPL.2/6/2022 dated June 22, 2022 regarding the Fourth Amendment to the decree of the Minister of Forestry No. SK.262/Menhut-II / 2004. The total area of PT Sumatera Riang Lestari is 173,971 Ha. The working area of PT Sumatera Riang Lestari Blok II Garingging is 42,075 Ha. In this decree, IUPHHK-HT nomenclature becomes PBPH (Business License for Forest Utilization). There was a conversion of natural forests into plantation forests above December 31, of 3,836.91 ha. Due to the conversion, the IFCC certified area becomes 38,684.24 Ha (42,521.15 Ha – 3,836.91 Ha).

PT Sumatera Riang Lestari Blok II Garingging runs forest management operations based on RKUPH documents of 2017 to 2026 approved by the decree of the Minister of Environment and Forestry SK.6479/MenLHK-PHL/PUPH/HPL.1/8/20228dated August 12, 2022. The Layout based on the document is Protected area of 8,552 Ha (20.33%) and Cultivation area of 33,523 Ha (79.67%), with a total of 42,075 Ha (100%). The protected area consists of river borders of 5,690 Ha (13.52%), KPPN/KPSL of 504 Ha (1.20%), and Other Protected Areas 2,368 Ha (5.60%). As for the Cultivation area, it consists of plantation area of 13,013 Ha (30.93%), LOA area for non-timber forest product of 70 Ha (0.17%), infrastructure of 427 Ha (1.01%), thicket and others of 20,013 Ha (47.57%).

The geographical area of PT Sumatera Riang Lestari Blok II Garingging is between 01°10'49" - 01°20'37" North and 99°47'31" - 100°06'28" East. It is part of Garingging River and Mahato River Forest Group. Based on government administration, it is in Lubuk Barumun District, Barumun Tengah District, Huristak District, Hutaraja Tinggi District, Padang Lawas Regency, North Sumatra Province.

The land conditions are dry/mineral soil with flat topography (0-8%) at an altitude of 75-280 masl. The soil type is podsolik, asosiasi podsol-gleisol-regosol, asosiasi gleisol-kambisol-aluvial. The climate classification includes a Type A climate with an average rainfall of 2,259 mm/year. The species of production plant developed is *Eucalyptus sp.*

Description of the socio-economic conditions of the concession and the concession's social programs

In general, the residents around the PT Sumatera Riang Lestari Blok II Garingging are local people (Mandailing Tribe) and immigrant communities (Javanese and Sundanese). There are no indigenous communities in and around the company. Most of the people make a living as oil palm farmers and rice farmers.

The Organization has made agreements on livelihood plant with three villages. There is no new cooperation agreement between the community and the company. There is utilization of non-timber forest product by the community. The types of identified non-timber forest product are fish, rattan and honey. The fish utilization is carried out by fishing and there is no use of poison.

The Corporate Social Responsibility Program of PT Sumatera Riang Lestari Blok II Garingging consists of education, health, religious, economic, infrastructure, and social and environmental sectors. The implemented assistance such as assistance for school facilities, baby complementary food, material assistance for building a village mosque, fish cultivation, village public facilities, and village youth equipment. Community Development Assistance Programs, in

general, are submitted by the community by making a proposal to the company. The Organization provide assistance in repairing village roads with the help of heavy equipment from the company.

Description of the Ecological conditions of the concession

The Organization conducts land cover identification and periodically conducts monitoring through the air, using fire towers, CCTV, drones and satellite image analysis. Allocating protected areas in areas that have ecologically important functions with the arrangement of working areas in accordance with the RKUPH for the period 2017 – 2026 by establishing protected areas of 8,522 Ha.

PT Sumatera Riang Lestari Blok II Garingging has been maintaining the health vitality of forest ecosystems by establishing operational standards that support the maintenance of the health and vitality of forests against adverse environmental factors and strengthening natural regulatory mechanisms, develop and implement documented waste management procedures including B3 waste, and regulate the use of chemical pesticides in the field with documented procedures.

The Organization has carried out appropriate maintenance, conservation and improvement for biodiversity in forest ecosystems, such as allocating and monitoring of protected areas as well as installing signboards, marking the boundaries and rehabilitation and enrichment of protected areas. The Organization also performed monitoring and maintaining of the endemic species.

PT Sumatera Riang Lestari Blok II Garingging has carried out protection function management activities with appropriate maintenance or improvement of protection functions, especially soil and water through:

- Reduced Impact Logging activities have been implemented to minimize the risk of degradation and damage to forest ecosystems.
- The operational work plan has been socialized every year and in particular there is a collective agreement for the protection of forests from forest fires and land together with communities around the concession. The mutual agreement between the community and the Organization is formed in the forum of Community with Fire Awareness (MPA).

Results of the Public Consultation

Prior to conducting Transition to IFCC ST 1001:2021 + Surveillance 2 Audit on PT Sumatera Riang Lestari Blok II Garingging, PT Acube TIC International has made a public announcement and public consultation. Invitation to public consultation to stakeholders to obtain input as materials/consideration through the website <u>www.ajaindonesia.com</u> on May 27, 2024. The stakeholders can provide input for audit considerations to PT Acube TIC International email. There is no input from stakeholders.

The audit team also collected information from the mass media about PT Sumatera Riang Lestari Blok II Garingging. The reported cases are considered as part of the PT Acube TIC International audit process.

The Organisation has identified all the necessary requirements for this certification process, which consist of legal aspects which include compliance with international rules and regulations and conventions. A management system has been developed to cover all activities in the area of certification, which are registered for the certification area of 38,684.24 hectares.

The result of Surveillance 1 Audit was one non-conformity. The Organization has made improvements and the non-conformity is closed.

The result of Transition to IFCC ST 1001:2021 + Surveillance 2 Audit is one non-conformity. The Organization has made improvements and the non-conformity is closed.
