#### **Brief Description of the concession**

PT Itci Hutani Manunggal received its forest management permit per Decree of the Minister of Forestry of the Republic of Indonesia Number 184 / Kpts-II / 1996 dated April 23, 1996. The operational implementation of the Company's working area is based on the Timber Forest Product Utilization Plan in Industrial Timber Plantations (RKUPHHK-HTI), This document may be revised in the case of changes in forest management. The latest document is RKUPHHK-HTI Revision of PT Itci Hutani Manunggal based on IHMB Year 2012. The period of 2008 - 2017 and its attachment has been approved per Decree of Minister of Forestry No: SK.55 / VIBUHT / 2012 dated 14 August 2012 and revised again in 2014 through SK Kepmenhut Number SK.53 / VI-BUHT / 2014 dated September 26, 2014. Short-term implementation is per the Annual Work Plan of Timber Forest Product Utilization..

Management of PT Itci Hutani Manunggal forest area of 161,127 ha divides the work area into three (3) management units, namely: Senoni Sector (76,204 ha), Sepaku Sector (43,437 ha) and Terunen Sector (41,486 ha). The Management Unit has determined the spatial arrangement of the total working area of 161,127 hectares to be: 1) Protected Areas of 17,443 ha (10.83%), 2) Production Areas, consisting of: Staple Crop Area of 91,887 ha (57.03%), Seed Plant Area of 19,261 ha (11.95%) and Livelihood Plant Area of 20,873 ha (12.95%), 3) Area Unsuitable for Production of 11,663 ha (7.24%).

PT Itci Hutani Manunggal is geographically located between 116° 25′ 21″ to 116° 52′ 15″ East and 00° 23′ 04″ to 01° 06′ 29″ South, bounded by:

North: Mahakam River, Other Use Areas (APL)

South: Bangkirai Penajam Hill Road, Production Forest (HP), Other Use Areas (APL)

West side: IUPHHK-HA PT ITCIKU, Other Use Areas (APL)

East: Balikpapan Bay, Production Forest (HP), Other Use Areas (APL)

The work area of PT Itci Hutani Manunggal falls under the governmental administration of the regencies of Kutai Kartanegara and Penajam Paser Utara, as detailed below:

- Senoni Sector: Kota Bangun District, Muara Muntai District, Muara Wis District, Sebulu District, Tenggarong District, Kutai Kartanegara Regency, East Kalimantan Province, Indonesia
- Terunen Sector: Loa Kulu District, Penajam Paser Utara Regency, East Kalimantan Province, Indonesia
- Sepaku Sector: Sepaku District, Kutai Kartanegara Regency, East Kalimantan Province, Indonesia

The physical condition of the work area of PT Itci Hutani Manunggal has a mostly sloping topography (44.93%), with flat (29.41%), slightly steep (21.80%), steep (3.22%) and very steep (0.64%) areas at an altitude ranging from 0 to 800 meters above sea level. According to the Schmidt-Ferguson classification, the area has a Type A Climate with a Q value of 0% to 4.3% and average annual rainfall of 1,998 mm / year.

# Description of the socio-economic conditions of the concession and the concession's social programs

There are 28 villages around the PT Itci Hutani Manunggal working area spread over 6 districts in 2 regencies. The communities surrounding the concession are mostly from the Kutai and Suku Pasir tribes, as well as Javan migrants from the transmigration program. The livelihoods of the population lie mostly in agriculture, plantations, forestry, hunting and fisheries. As well as the mining sector, others find livelihood in restaurants and accommodation services. Good relationships have been built between the Company and society with the development of life created through SPK (Letter of Cooperation Affairs)

The Management Unit has a conflict resolution process already in place that records chronological events, maps of conflict area maps and minutes of meetings. The mechanism of the conflict resolution was partially developed and agreed between the Management Unit and the local community

The Management Unit has a Community Development (CD) program in the areas of: economics (agriculture and

agroforestry, fisheries and animal husbandry, and small and medium enterprises), basic social services (education, health, religious, national holidays), and village infrastructure, culture and sport.

### Description of the ecological conditions of the concession

The Management Unit has identified important forest management activities, and conducted an environmental impact assessment, as outlined in AMDAL environmental documents, RKL (Environmental Management Plan), RPL (Environmental Monitoring Plan). The impacts of forest management as affect the following areas: rate of erosion, sedimentation rate of water quality, structure and vegetation, non-timber forest products, wildlife and their habitats. Environmental monitoring activities include: monitoring of erosion, water quality, water discharge, sediment, vegetation, wildlife, and pests and diseases.

Management Unit has identified potential forest disturbances, one of which being forest fires. Mitigation efforts in respect to the potential of forest fires include:

- Preparation of maps of fire prone areas and monitoring of daily fire hazard indices
- Emergency team training
- Provision of adequate fire equipment
- Routine patrols.
- Maintenance of access to HTI concession areas
- Installation of fire warning signs and wildlife hunting boards in PT Itci Hutani Manunggal
- Determination of water sources (water points) and water stations
- Direct fire outages in the field up to a 200 m radius from the concession boundary
- Establish forest fire posts in areas where there is a potential for fires
- Making fire breaks
- Socialization to the community about the burning of gardens / fields
- Use drone to monitor hotspots
- MPA Socialization and formation of community groups concerning fire:
- Coordination of the parties in the handling of firefighting (forestry officers, police and other relevant agencies)

#### **Results of the Public Consultation**

Prior to conducting the Surveillance 1 Audit, PT AJA Sertifikasi Indonesia carried out public consultation, commencing November 1, 2016 in which stakeholders were invited to provide feedback on PT Itci Hutani Manunggal. Announcement of the public consultation was published on the website of PT AJA Sertifikasi Indonesia (<a href="www.ajaindonesia.com">www.ajaindonesia.com</a>), sent to the parties by email or letter and published in the local newspaper. All responses from stakeholders were input for consideration in conducting the Surveillance 1 Audit, and suggestions and feedback were followed up by the audit team during the field validation.

The audit team also gathered information from the mass media on PT Itci Hutani Manunggal, which was considered as material during the audit process

PT Itci Hutani Manunggal has identified all the necessary requirements for this certification process, comprising legal aspects that include compliance with regulations and international rules and conventions. The management system has been built to cover all activities in the field of certification, which is registered for certification of an area of 161,127 ha.
