Brief Description of the concession and its natural and socio-economic conditions.

PT Mutiara Sabuk Khatulistiwa was granted a forest management operating license by the Decree of the Business License Timber Forest Products in Natural Forest of the Forestry Minister: Minister of Forestry Decree 109 / Kpts-II / 2000 date. December 29, 2000, with an area of 44, 595 ha. Spatial consist of: effective area TPTI 11,450 ha, effective area THPB 20,760 ha, protected area 7,820 ha (border Gaung River 1,796 ha, border Simpang Kanan River 1,747 ha, KPPN / germplasm conservation areas 535 ha, DPSL / wildlife protection area 3,742 ha), non-forest rehabilitation of 1,987 ha, area unsuitable for operation 2,454 ha.

In 2013, by the Decree of the Minister of Forestry of the Republic of Indonesia Number: SK.59 / Menhut-II / 2013 dated January 23, 2013 on "The determination of the working area permit the results of Utilization of Timber Forest in Natural Forest PT Mutiara Sabuk Khatulistiwa measuring 44,433.66 (forty-four thousand four hundred and thirty-three point sixty-six) hectares in Riau Province.

Under the requirements of the IFCC Standard, PT Mutiara Sabuk Khatulistiwa has excluded from certification the areas of plantation forest (10,759 ha) that were established through conversion of natural forest after Dec 31, 2010. The final scope of certification is thus 33,674.66 hectares. PT Mutiara Sabuk Khatulistiwa has since made a commitment to stop deforestation.

PT Mutiara Sabuk Khatulistiwa is in the public administration of Echoes sub-district, Indragiri Hilir district, Riau Province. Geographically located $00^{\circ}05'$ - $00^{\circ}51'$ S; $102^{\circ}03'$ - $103^{\circ}03'$ E, including the watershed (DAS) Gaung, forest group Gaung-Sungai Simpang Kanan. Working area boundaries: North: PT Bhara Induk, East: the State Forest, West: the State Forest and South of the Gaung River and PT Bina Duta Laksana.

Based on the Social Impact Assessment Report (2014) the people living around the working area of PT Mutiara Sabuk Khatulistiwa consist of Malay (15%), Javanese and Sundanese (3%), Banjar (75%), Minang (1%), Bugis (2%), Tionghoa, Batak, Palembang (4%). There are eight (8) village built MU namely: Teluk Kabung village, Simpang Gaung village, Pungkat village, Belanta Raya village, Lahang Baru village, Kuala Lahang village, Pintasan village, and Semambu Kuning village.

MU efforts made to minimize the negative impact on the social aspects are:

- 1. Watering of the roads
- 2. Assistance by means of the provision of a water pump
- 3. Open access for the local community to take advantage of non-timber forest products
- 4. An opportunity for people to work in forest management activities (planting, harvesting, security, firefighting team), or also as a supplier.

PT Mutiara Sabuk Khatulistiwa has developed the following institutional groups:

- 1. Farmers, comprising four (4) groups for the cultivation of curly chili, areca nuts and fruit tree cultivation, and fisheries.
- 2. Cooperative, three (3) groups comprising plantation and management, building construction, and road watering.
- 3. Business partner, consisting of one (1) group in the tailoring business.
- 4. One group consisting the livestock cultivation of goats.

PT Mutiara Sabuk Khatulistiwa has entered into agreements with the local communities for Activity Local Communities, such as access to roads, access to canal, P3K clinic, mosque and church facilities, sports hall, land and air transport, together with watering of the road, effective January 1, 2014 until September 31, 2017.

Sustainable forest management will have an impact on environmental components, Component / Sub-Component / Environmental Parameters affected being as follows:

- Physical-Chemical, including micro-climate, land physiography, soil (physical and chemical properties, subsidence, erosion), hydrology (run-off current, water fluctuation, sedimentation), water quality.
- Biological Component: including vegetation (potential and non-timber forest products), wildlife (habitat, species, concentration, range), aquatic biota (abundance & diversity)

Management and monitoring efforts conducted MU PT Mutiara Sabuk Khatulistiwa, include among others:

- 1. Management of protected areas (KPPN/Germplasm conservation areas, DPSL/ wildlife protection area, river border)
- 2. Management of important impacts: ecosystem function, physical-chemical nature of soil and water quality, waste B3, protection of forests, flora and fauna
- 3. The management of waste materials and B3

Efforts are being made to implement the Report of the Environmental Management Plan (RKL) and Environmental Monitoring Plan (RPL) are conducted each semester and reported regularly to the Regional Environmental Agency (BPLHD). MU is committed to minimizing the environmental impact caused by its forest management.

Before performing its Stage 2 audit, PT AJA Sertifikasi Indonesia made a public announcement and public consultation through its website www.ajaindonesia.com on November 20, 2015.

In addition to its website announcement, public consultation was also carried out through the local print media and direct invitations to stakeholders. The print media used was the Riau Pos issue of October 11, 2015 on page 5. Stakeholders were invited for public consultation through letter No. 548-588 / AJAINDO / DIRUT / X / 2015 dated October 12, 2015.

Prior to the audit stage 2, the stakeholders had the opportunity to provide input from December 2 to 5, 2015. Their suggestions related to: developing the villages surrounding MU's working area, providing business opportunities through

CSR, distribution of levy from TPK Antara / dock loading and unloading for donation to (SMK development, early childhood development [early childhood education], scholarships, construction of student dormitories, and research funding for local institutions).

In the stage 2 audit verification of stakeholder input, the policy directive of PT Mutiara Sabuk Khatulistiwa contains policies to: 1) give priority to local workers; 2) an attitude of non-discrimination; 3) not employ child labor;4) provide freedom of assembly and association, and; 5) not use forced labor. In addition, PT Mutiara Sabuk Khatulistiwa also ensures that workers' rights are properly fulfilled in accordance with the ILO and the regulations of the Indonesian Ministry of Labor. Some of the activities conducted MU include: watering of the roads; cultivation of chili; development of a tailoring business; goat raising program, venture capital assistance, health / medicine. The provision of funds to meet the expectations expressed by the stakeholder, however, remains within the province of the government.

Findings on the certified client certified client conformity with the certification requirements and description of critical issues in relation to the conformity.

The results of stage 2 audit revealed non-conformities in five (5) minor categories. MU has committed to rectify these matters by taking corrective action:
