Brief Description of the Concession

PT Rimba Peranap Indah obtained its first concession permit based on the Decree of the Minister of Forestry No: 598/Kpts-II/1996, on September 16, 1996. The location of PT Rimba Peranap Indah is in Ukui District of Pelalawan Regency and District of Peranap, Kelayang, Lubuk Batu Jaya of Indragiri Hulu Regency, Riau Province. The latest decree of the concession is the Decree of the Minister of Forestry No.1616/Kpts-II/2001, dated October 31, 2001, concerning the Determination of the Work Area Boundaries of PT Rimba Peranap Indah of 14,434 Ha in Riau Province. The area of 14,434 ha is being certified by IFCC due to no conversion of natural forest after December 31, 2010.

The Management Unit's ten-year plan (RKUPHHK-HTI) for the period of 2020 to 2029 is issued based on the Decree of the Minister of LHK No. SK.10207/MenLHK-PHPL/UHP/HPL.1/12/2019 dated December 18, 2019. According to the RKUPHHK-HTI, the spatial arrangement is divided to Protected Area of 2,263 ha (15.68%) and the cultivation area of 12,171 ha (84.32%).

The operational activities cover two regencies and falls into its government administration, namely in Ukui District of Pelalawan Regency and District of Peranap, Kelayang, Lubuk Batu Jaya of Indragiri Hulu Regency, Riau Province. The work area is geographically located between 0° 20' to 0° 28' South to 101° 54' to 102° 5' East, and is part of the Tesso Nilo Forest Group.

The area has a flat topography with an altitude of 54,144 m above sea level. The soil type is red-yellow podsolic and crossed by Sei Hitam Kanan River, Garingging River, Terentang River, Limbat River and Sibungkul River. The climate type according to the Schmidt and Fergusson is classified as type A. The land type is a 100% dry/mineral and the production plants developed are *Acacia mangium* and *Eucalyptus* sp.

Description of the socio-economic conditions of the concession and the concession's social programs

There are ten assisted villages spread over two regencies, namely:

- Village of Baturijal Barat, Baturijal Hulu, Lubuk Batu Tinggal, Pandanwangi, Semelinang Darat and Sereh Wangi in Indragiri Hulu Regency,
- Village of Bagan Limau and Lubuk Kembang Bunga in Pelalawan Regency.

There are no customary law communities around the concessions. This is according to the previous year audit and the field verifications. The result of the interview shows that livelihoods of residents are mostly self-employed (traders, workshops) and day laborers other than farmers, employees for the local companies and civil servants.

PT Rimba Peranap Indah has made efforts to resolve conflicts with the surrounding community. Based on the Potential Mapping and Conflict Resolution Reportof 2021, the conflict situation around the company is in a critical condition. The situation is being handled by the Management Unit through some approaches to the community. PT Rimba Peranap Indah has collaborated with the surrounding community, such as livelihood plant cooperation. The company has submitted the livelihood plant fee for the RKT 2020 to the village.

PT Rimba Peranap Indah has implemented a Corporate Social Responsibility (CSR) program for the surrounding community. According to the realization report of 2021 and the village heads, the CSR programs being implemented in 2021 include in the sector of economic, religious, and infrastructure. Based on the plans for the CSR program in 2021, the realization of the CSR program has reached 90% of the planned.

Description of the Ecological conditions of the concession

The Management Unit has carried out forest ecosystem and hydrological function management. The management is conducted through the initial identification of forest management activities that have significant impact and conduct environmental impact assessments through the addendum of ANDAL, RKL and RPL. The implementation of

environmental management and monitoring every semester is presented in the Environmental Permit Implementation Report (RPL/RKL). The allocation of protected area which consists of a river border of 1,567 ha (10.86%), KPPN of 681 ha (4.72%) and infrastructure facilities of 15 ha (0.10%). The river border and KPPN area is also allocated as soil and water protection. The Management Unit applies Reduced Impact Logging, which is implemented before, during and after logging activities. The negative impacts of forest management activities in the concession area are being monitored in accordance with the ANDAL, RKL and RPL. As for monitoring of protected areas, water quality and erosion, the Management Unit has documented procedures that serve as guidelines for monitoring negative impacts due to forest management.

The biodiversity management activities are implemented through identification and inventory of protected, endemic, rare and threatened/near-extinct flora and fauna as well as their habitats and migration pattern in the IUPHHK-HTI area. The results of the identification and inventory can be found in the Addendum of ANDAL, RKL and RPL report of 2021, and a fauna distribution map and a flora distribution map. The Management Unit has carried out an environmental impact assessment on the potential impacts on flora and fauna and not cultivating the genetically modified tree species but *Acacia mangium* and *Eucalyptus* sp.

The Management Unit has carried out forest protection activities through identification and monitoring of disturbances in sustainable forest management. The forest protection as well related to the weed control, toxic and hazardous waste management, pest and disease management, which activities are referred to the SOP. There is also forest protection measures against fire hazards and livestock grazing activities by the community.

Results of the Public Consultation

Prior to carrying out the Recertification Audit, PT AJA Sertifikasi Indonesia conducted a public consultation starting March 14, 2022, asking stakeholders to provide feedback and information on PT Rimba Peranap Indah. The public consultation was uploaded to the PT AJA Sertifikasi Indonesia website (<u>www.ajaindonesia.com</u>), sent to parties via email or postal mail, and published in local newspapers. PT AJA Sertifikasi Indonesia did not receive input from stakeholders during the public consultation.

The audit team also collects information from the mass media about PT Rimba Peranap Indah. The reported cases are considered as part of the PT AJA Sertifikasi Indonesia audit process.

The Management Unit has identified all the requirements needed for this certification process, which consists of legal aspects which include compliance with international regulations and rules and conventions. The management system has been built to cover all activities in the certification field, registered for certification covering an area of 14,434 hectares.


Findings on the certified client conformity with the certification requirements and description of critical issues in relation to the conformity.
