Brief Description of the concession

PT Sumalindo Hutani Jaya II obtained a Business Permit for Timber Forest Product Utilization in Industrial Plantation Forests (IUPHHK-HTI) per Decree on the Granting of Concession Rights in Industrial Plantation Forest over an area of 70,300 hectares in the Province of East Kalimantan to PT. Sumalindo Hutani Jaya from the Minister of Forestry Decree No.675 / Kpts-II / 1997 on October 10, 1997.

PT Sumalindo Hutani Jaya II has a document on the Revision of the Work Plan for the Utilization of Plantation Forest Products (RKUPHHK-HT) for the Period of 2017-2026 with Decree Number of the ratification SK 111 / MenLHK-PHPL / UHP / HPL.1 / 1/2018.

PT Sumalindo Hutani Jaya Unit II's Spatial Planning Arrangement for the 2018-2027 period is as follows: Local Protected Areas and other Protected Areas covering an area of 18,023 ha (25.64%), Staple Plants covering an area of 21,469 ha (30.54%), Livelihood Plants covering an area of 24,287 ha (34.55%), Borrow-to-Use Forestry Permit (IPKKH) covering an area of 6,521 ha (9.28%), totaling 70,300 ha (100.01%); percentage difference due to rounding.

Other Local Protected Areas and Protected Areas consist of: 5,260 ha of Wildlife Protection Area (7.48%), 6,371 ha of Germplasm Conservation Area (9.06%), 3,059 ha of Riparian (4.35%), Buffer zone with 576 ha (0.82%), Soil Conservation with 75 ha (0.11%), Slope E area with 2,630 ha (3.74%), and water spring of 52 ha (0.07%)

There has been conversion of 544 hectares of natural forest to plantation forest since December31, 2010. Thus, the scope of IFCC certification is for an area of 70,300 ha - 544 ha = 69,756 ha.

Geographically the work area is located between 00° 05' 57.66" to 00° 22' 16.40" South and 117° 06' 14.56" to 117' 24' 27.92" East. The work area is bounded to the west by PT Surya Hutani Jaya, to the east by Production Forest of Inhutani I and PT Perkebunan XXVI concessions, to the north by Production Forest and Protection Forest of Bontang.

In regard to governmental administration, PT Sumalindo Hutani Jaya II is located in Sebulu District, Muara Kaman District, Tenggarong Seberang District and Muara Badak District, Kertanegara Regency and Muara Bengkal District, East Kutai Regency.

The concession area has Climate type A with value of Q = <14.3% and an average temperature of 31.9° C. Topography consists of slope class A (13.22%), slope class B (38.60%), slope class C (37.19%), slope class D (8.67%), and slope class E (2.32%) at an altitude of 17 to 290 meters above sea level. Geologically formed of Pamaluan formation, lake sediments, dangkan sandstone, Bebuluh formation, Balikpapan formation, and Balaubalang formation. The dominant soil types are Tropudults and Dystropepts. From a hydrological aspect, the work area is affected by the Estuary of the Mahakam River, Sambera watershed, Santan watershed, Marangkayu watershed, Mahakam watershed.

Given the foregoing, thr species of plants cultivated for wood production is *Eucalyptus* sp..

Description of the socio-economic conditions of the concession and the concession's social programs

Based on the administrative area, the concession area of PT Sumalindo Hutani Jaya II falls under the District of Sebuluh, Tenggarong Seberang, Marangkayu, and Muara Badak, Kutai Kartanegara Regency, East Kalimantan Province. There are 14 villages located around the work area.:

- 1. Two villages of Sebuluh District : Segihan and Giri Agung Village.
- 2. Four villages of Tenggarong Seberang District: Bhuana Jaya, Bukit Pariaman, Mulawarman, and Separi Village.
- 3. Six villages of Marangkayu District: Perangat Baru, Perangat Selatan, Santan Ilir, Santan Tengah, Santan Ulu, and Sebuntai Village.
- 4. Two villages of Muara Badak District: Sukadamai and Badak Mekar Village.

The indigenous people of East Kalimantan who live around the concession are the Kutai, the remainder being Javanese,

Batak, Banjar, Manado and Sundanese migrants. Most Kutai people in the villages have established cordial relations with the migrant communities. In forest management, the Management Unit involves the surrounding community with collaborative livelihood plants in the form of rubber plants, fern roots and fish utilization.

Based on reports about the realization of the 2017 and 2018 CD-CSR programs, the Management Unit has provided assistance in the form of books and other teaching aids, traditional ritual assistance, religious assistance, mass circumcision, scholarship assistance, teacher salaries, mosque building, and qurban animal assistance. There is a program plan for the DMPA (Desa Makmur Peduli Api), which has received approval of financial program from the Management Unit in the form of tilapia cultivation, horticulture cultivation, goat farming, and purchase of fish pellet machines and materials. In addition, PT Sumalindo Hutani Jaya II has helped to register and pay for the Health Insurance of 30 needy people living in the surrounds of the concessions.

Description of the ecological conditions of the concession

Based on the estimated significant impact matrix, forest management activities that have significant impacts include land preparation, planting, maintenance, harvesting and protection of the forest from disturbance, either natural or man-made.

The Management Unit monitors several components of environmental impacts that include:

- a. Physical-Chemical Components (micro air temperature & humidity in areas effective for production, soil erosion in areas effective for production and not effective for production, sedimentation and water quality in areas effective for production)
- b. Biological Components (diversity of vegetation and wildlife species in protected areas, potential timber / stands and pests & plant diseases in areas effective for production)

Besides introducing Reduced Impact Logging, the Management Unit has operational standards for the use and storage of hazardous materials (B3). It is also committed to the rehabilitation and restoration of protected areas, and has identified and monitors the endemic flora and fauna to be found in these areas.

In relation to forest protection, the Management Unit ensures the installation and maintenance of boundary signs for protected areas, as well as warning and prohibition signs against incursions, lighting of fires, illegal logging, unauthorized grazing, hunting, etc. and regular patrols are carried out to enforce the regulations.

Results of the Public Consultation

Prior to conducting the Recertification Audit, PT AJA Sertifikasi Indonesia conducted a public consultation commencing July 18, 2018, asking stakeholders to provide feedback and information about PT Sumalindo Hutani Jaya II. The public consultation was uploaded to the PT AJA Sertifikasi Indonesia website (<u>www.ajaindonesia.com</u>), sent to parties via email or postal mail, and published in local newspapers. PT AJA Sertifikasi Indonesia did not receive any input from stakeholders as a result of the public consultation.

The audit team also gathered information from the mass media about PT Sumalindo Hutani Jaya II, the reported cases being given material consideration as part of the audit process of PT AJA Sertifikasi Indonesia.

The Management Unit has identified all the requirements required for this certification process, comprising legal aspects that include compliance with international regulations, rules and conventions. The management system has been built to cover all activities in the field of certification, which is registered for an area of 69,756 hectares.

Findings on the certified client conformity with the certification requirements and description of critical issues in relation with the conformity.

The results of the Surveillance 2 Audit of PT Sumalindo Hutani Jaya II revealed seven (7) Minor Non-Conformities (NC). The Management Unit has noted and since addressed these issues. No critical issues were identified during the audit.
