Brief Description of the concession

based forest management permit is on Decree of Pelalawan 522.21/IUPHHKHT/1/2003/015 dated January 30, 2003 of 3,300 Ha located in Pelalawan District, Pelalawan Regency, Riau Province. The area size is based on the Report on the Results of Self-Delimitation Arrangement and Work Area Partnership Business Permit for Utilization of Timber Forest Products in Industrial Plantation Forests (IUPHHK-HTI) CV Alam Lestari with PT Riau Andalan Pulp and Paper, CV Bhakti Praja Mulia, PT Madukoro in Pelalawan Regency, Province Riau with Report No. LP.012/BPKH.XIX/PKH/-/8/2016 of 4,868.65 Ha. Based on SK981/MENLHK/SETJEN/PLA.2/11/2019 dated 7 November 2019 concerning Determination of Work Areas for Utilization Permits for Timber Forest Products in CV Alam Lestari Plantation Forests of 4,868.65 Ha in Pelalawan Regency, Riau Province. CV Alam Lestari received the latest concession permit of PBPH SK:No.805/MENLHK/SETJEN/HPL.0/9/2021 dated 21 September 2021 with an area of 4,868.65 Ha. In this decree there is a change in nomenclature from IUPHHK-HT to PBPH (Forest Utilization Business Permit). There are no natural forest conversion areas above 31 December 2010, thus, the scope of certification is 4,868.65 ha.

The Organization has a ten-year management plan, namely the Revised Work Plan for the Utilization of Industrial Timber Forest Products (RKUPHHK-HTI) ratified by Decree 6059/MenLHK-PHPL/UHP/HPL.1/6/2019 dated 28 June 2020. According to the document, there have been changes to the spatial layout namely Local Protection Areas and Other Protected Areas of 1,010.65 ha (20.76%), Staple Plant area of 3,097.00 ha (63.61%) and Livelihood Plant Areas of 761.00 ha (15.63%). To fulfill the 20% Livelihood Plant allocation, it is fulfilled from the Protected Area in the form of utilizing NTFPs. The short-term plan was made in the 2023 RKTPH Book which was ratified by the Decree of the Director of CV Alam Lestari Number: 88/SK/AL/XII/2022 dated 28 December 2022 concerning Approval of the 2023 Annual Work Plan for Forest Utilization.

CV Alam Lestari is geographically located between the coordinates 00°33'44" to 00°25'30" North and 102° 15'59" to 102° 20'24" East. Administratively, the CV Alam Lestari work area is located in Pelalawan District, Pelalawan Regency, Riau Province. CV Alam Lestari is surrounded by Industrial Plantation Forest companies, namely:

- North side: IUPHHK-HT CV Bhakti Praja Mulia,
- South side: IUPHHK-HT PT Riau Andalan Pulp and Paper,
- East side: IUPHHK-HA Yos Raya Timber (PT Gemilang Cipta Nusantara), and
- West side: IUPHHK-HT PT Riau Andalan Pulp and Paper.

The Organization has complied with regulations related to peatland management. CV Alam Lestari has carried out: Revision of the RKUPHHK in the context of improving Peat Governance based on the Decree of the Minister of Environment and Forestry of the Republic of Indonesia Number SK.942/MenLHK/Setjen/UHP/HPL.1/3/2018 dated March 2, 2018. Preparing an Implementation Report Restoring Peat Ecosystems and Controlling Forest and Land Fires based on Decree of the Director General of Pollution and Environmental Damage Control No. 102/PPKL/PKG/PKL.05/10/2018 dated 21 September 2018. Revised the RKUPHHK for the 2017-2026 period based on the Decree of the Minister of Environment and Forestry of the Republic of Indonesia Number SK. 6059/MenLHK-PHPL/UHP/HPL.1/6/2019 Dated 28 June 2019. There is no peat dome peak. Based on the site the species developed is *Acacia crassicarpa*.

Description of the socio-economic conditions of the concession and the concession's social programs

The residents around CV Alam Lestari are local communities. There are two villages around the concession, namely Sungai Ara Village and Ransang Village in Pelalawan Regency, Riau Province. Based on the RKUPHHK HTI Document for the 201702026 Period of CV Alam Lestari, the livelihoods of residents in the two villages around CV Alam Lestari are in the

Agriculture and Trade Sectors. There are no conflicts within the CV Alam Lestari concession. Based on the Potential Mapping and Conflict Resolution Report of CV Alam Lestari Semester I of 2023, the Potential Conflict Status of CV Alam Lestari is Safe, there are no conflicts and there are no claim areas within the CV Alam Lestari concession.

CV Alam Lestari has entered into a cooperation agreement with the surrounding community. There is a Livelihood Plants Agreement between CV Alam Lestari and two villages around the concession. There is evidence of the handover of the benefits of the livelihood plants to the village. Based on interviews with the village heads, both villages admitted that they had received the benefits.

Based on the 2022 Community Development Program Report, the activities carried out were student equipment, health equipment, village office equipment, cooking oil market operations. Meanwhile based on the 2023 Report, the activities that have been carried out are school equipment and lawn mower assistance for the village.

Description of the Ecological conditions of the concession

The Organization has carried out forest ecosystem and hydrological function management through the following activities:

- Identify forest management activities that have significant impacts and carry out environmental impact assessments through AMDAL, RKL and RPL Documents. The implementation of environmental management and monitoring each semester is presented in the Environmental Permit Implementation Report (RPL/RKL).
- Reduced Impact Logging activities have been implemented to minimize the risk of degradation and damage to forest ecosystems that have been adapted to peatland conditions.
- Identify areas that function to protect land and water. The designated protected area allocation is Local Protected Areas and Other Protected Areas of 1,010.65 ha (20.76%) consist of River Borders of 212.00 ha (4.35%), KPPN/KPSL of 163.00 ha (3.35%) and Other Protected Area of 635.65 ha (13.06%).
- Identification of areas that contribute to global emissions in the Draft Integrated HCV-SKT Assessment Report in Five Plantation Forest Concessions, Riau Province: CV Tuah Negeri, CV Alam Lestari, CV Bhakti Praja Mulia, CV Mutiara Lestari and PT Selaras Abadi Utama 2022.
- Monitoring of negative impacts of forest management activities in concession areas is carried out in accordance with the AMDAL, RKL and RPL and documented procedures that serve as guidelines for carrying out impact monitoring activities, namely SOP for Management and Monitoring of Protected Areas, SWater Table Monitoring OP, SOP for Water Discharge and Quality Monitoring.
- CV Alam Lestari has documented procedures for the controlled use of B3 (Hazardous and Toxic Materials), namely SOP for Management of Hazardous and Toxic Waste (B3), SOP for Handling Spills of Fuel, Lubricants and Chemicals, SOP for Household Waste Management, and SOP for Integrated Pest and Disease Management.
- CV Alam Lestari has an encouraging monitoring program for positive climate practice in forest management activities including weather monitoring (temperature, CH, and temperature), air monitoring, identifying sources of greenhouse gas emissions. Establish SOPs for monitoring ambient air quality, testing vehicle exhaust emissions and stationary source emissions.

The Organization has carried out biodiversity management through the following activities:

- Identification and inventory of protected, endemic, rare and threatened/endangered flora and fauna as well as their habitat in the IUPHHK-HTI area. The results of the identification and inventory can be found in AMDAL, RKL and RPL Implementation Report (Semester 2, 2022 and semester 1, 2023). The organization has updated data on high conservation value and high carbon stocks contained in Draft Integrated HCV-HCS Assessment Report.

- Identify key species along with their habitats and migration patterns. Based on this identification, there are key species in the area, namely sumatran tiger (*Panthera tigris sumatrae*) and hornbills (*Buceros* sp.).
- Has carried out an environmental impact assessment of the potential impact on protected, endemic, rare flora and fauna and threatened/endangered species.
- The species of staple crops cultivated are not genetically modified tree species but Acacia crassicarpa.

The Organization has implemented appropriate and measurable steps through forest protection activities, namely:

- Identify and monitor disturbances in sustainable forest management. Based on document review and field verification, forest disturbances generally originate from Internal factors are caused by the establishment of camps in and around protected areas/conservation areas, damage by heavy equipment and logging as a result of harvesting activities. Meanwhile, external factors are caused by illegal logging activities, encroachment, fires, damage due to natural factors such as wind, attacks by wild animals, pest attacks and plant diseases.
- Have documented procedures to prevent and handle pest and disease attacks, namely SOPs for Integrated Pest and Disease Management, SOPs for Forest Protection, SOPs for Controlling Forest and Land Fires.
- Regulate the management of chemical pesticides in the field with documented procedures and MSDS.
- Has implemented forest protection measures against fire hazards which have been referred to Minister of Environment and Forestry Regulation Number P.32/MenLHK/Setjen.Kum.1/3/2016 concerning Control of Forest and Land Fires.
- In the work area there are no livestock grazing activities by the community and the use of NTFPs is monitored by the Forest Protection team. The NTFPs used by the community are fish.

Results of the Public Consultation

Prior to carrying out the Transition to IFCC ST 1001:2021 + Surveillance 1 Audit, PT ACube TIC International conducted a public consultation starting November 24, 2023, asking stakeholders to provide feedback and information about CV Alam Lestari. The public consultation was uploaded to the PT ACube TIC International website (www.ajaindonesia.com), sent to parties by email or postal mail, and published in local newspapers. There was no input from the stakeholders.

The audit team also collected information from the mass media about CV Alam Lestari. The reported cases are considered part of the PT ACube TIC International audit process.

The Organization has identified all the requirements necessary for this certification process, which consists of legal aspects that include compliance with regulations and international rules and conventions. The management system has been built to cover all activities in the field of certification, which are registered for certification covering an area of 4,868.65 hectares.

Organization progress record related to corrective action on findings of nonconformities in previous audit

The result of Recertification Audit was 3 (three) non-conformities in Minor categories.
