Brief Description of the concession

PT Nusa Prima Manunggal received Industrial Timber Forest Product Utilization Business Permit (IUPHHK-HTI) based on the Decree of the Regent of Pelalawan Number 522.1/Dishut/XI/2002/002 dated November 12, 2002 concerning the Granting of Timber Forest Product Utilization Business Permit Rights to PT Nusa Prima Manunggal Gross Area ± 4,412 (Four Thousand Four Hundred Twelve) Hectares, Net Area ± 3,600 (Three Thousand Six Hundred) Hectares in Pelalawan Regency. In 2018, PT Nusa Prima Manunggal received the Decree of the Minister of Environment and Forestry No. SK.463/MenLHK/Setjen/PLA.2/11/2018 dated November 5, 2018 concerning the Determination of the IUPHHK-HTI Work Area of PT Nusa Prima Manunggal covering an area of 4,289 Ha in Pelalawan Regency, Riau Province. PT Nusa Prima Manunggal received the latest is the Decree of the Minister of Environment and SK.1126/MENLHK/SETJEN/HPL.0/11/2021 dated November 17, 2021 concerning Business Licensing for Forest Utilization of PT Nusa Prima Manunggal, in this decree there is a change in nomenclature from IUPHHK-HT to PBPH (Forest Utilization Business Permit). The area based on permit is 4,289 ha. The forest area and the certified area is 4,289 ha with reference to the condition that no natural forest was converted after 31 December 2010.

The Organization has documents changes to the RKUPH which is authorized by the Decree of the Minister of Environment and Forestry of the Republic of Indonesia No. SK.46999/MenLHK-PHL/PUPH/HPL.1/4/2023 dated April 4, 2023 concerning Changes to the Work Plan for Utilization of Results for the 2017-2026 Period on behalf of PT Nusa Prima Manunggal. Short-term planning is made into a RKTPH (Annual Forest Utilization Work Plan) document:

- 1. RKTPH 2024: Director's Decree No. 02/NPM-Dir/I/2024 dated January 10, 2024 concerning the 2024 Annual Work Plan for Forest Utilization
- 2. RKTPH 2025: Director's Decree No. 01/NPM-Dir/I/2025 dated 31 December 2025 concerning the 2025 Annual Work Plan for Forest Utilization

The organization's work area is divided into two main zones: Protected Areas and Conservation of Wild Plants and Animals, covering 610 Ha (14.23%), and the Cultivation Area, which spans 3,679 Ha (85.78%). The Protected Areas include the KPPN area (3 Ha, 0.07%), the River Boundary area (590 Ha, 13.76%), and the Peat Ecosystem Protection Function Area (17 Ha, 0.40%). The Cultivation Area consists of the Utilization of Cultivated HHK (Plantation Forest) area, which covers 3,574 Ha (83.35%). This area is further subdivided into the Self-Managed Area (2,194 Ha, 51.17%) and the Forestry Partnership Area (1,380 Ha, 32.18%). Additionally, there is an Infrastructure area of 105 Ha (2.45%). In total, the work area covers 4,289 Ha (100%).

Based on interviews with the organization's staff and the village representatives, the formation of PT Nusa Prima Manunggal originated from a collaboration between the Pangkalan Gondai village community and PT Nusa Prima Manunggal. The community, who owned land, sought to cooperate with the organization, leading to the establishment of PT Nusa Prima Manunggal, which operates in the industrial forest plantation sector. As a result, the fostered village for the organization is Pangkalan Gondai Village, located in Langgam District, Pelalawan Regency. The work area of PT Nusa Prima Manunggal, based on government administration, is located in Pangkalan Gondai Village, Langgam District, Pelalawan Regency, Riau Province, with administrative oversight from the Riau Province Environment and Forestry Service. Geographically, the location is situated at coordinates 00°02'04.795" N - 00°06'50.651" N and 101°46'18.285" E - 101°53'37.000" E.

The work area has a flat topography which consists of Red Yellow Podsolic soil. The geological formations including Minas, Petani (Tup), Young Alluvial and Shallow Peat elements. It is at an altitude of 20-160 m. It is flowed by Tesso watershed and is a part of Tesso Forest Group. The climate is A with rainfall of 2,442 mm/year. The types of plants developed are Acacia crassicarpa and Eucalyptus sp.

Description of the socio-economic conditions of the concession and the concession's social programs

The population around the concession is local communities. There are no customary law communities around the Organization's concession area. Based on the Environmental Permit Report for Semester II of 2024, the livelihoods of the residents of Pangkalan Gondai Village are dominated by livelihoods in the agricultural sector of 1,337 people. Furthermore, the livelihoods of individuals include 552 employees, 208 entrepreneurs, 59 traders, 10 fishermen (river), 11 civil servants, and 4 people working in services.

PT Nusa Prima Manunggal has a mechanism for resolving complaints, grievances and disputes regarding land ownership, forest management and working conditions. Based on the Report on Mapping Potential and Conflict Resolution for Semester II of 2024, the Organizational conflict potential value is Controlled. Based on interviews with surrounding villages and Organization workers, the establishment of the company was based on cooperation between the company and the Pangkalan Gondai village community. Based on the agreement, all concession land belongs to the Pangkalan Gondai community which was agreed upon based on the agreement to carry out forest management cooperation.

PT Nusa Prima Manunggal has collaborated with the surrounding community. There is Evidence of Notarial Deed of Forestry Business Cooperation Agreement dated February 21, 2001. This agreement was made between the Village Unit Cooperative and PT Nusa Prima Manunggal. The agreement outlines that the First Party, holder of customary rights in Pangkalan Gondai Village, grants the Second Party management and exploitation rights over the forests in the customary land area. The Second Party is responsible for all permit management, investment costs, and operations related to the Mixed Plantation Forest Concession Rights (HPHTC). The agreement is for 35 years, plus an additional 8-year planting cycle, and can be extended by mutual agreement after the term ends.

PT Nusa Prima Manunggal has implemented a corporate social responsibility program for the surrounding community. According to the 2024 Community Development Program Report, several community development initiatives are underway to improve infrastructure and provide essential services. These include the construction of a canal to enhance water management, road maintenance for proper watering, and beverage assistance during Eid al-Fitr celebrations. Medical aid is being organized with the help of local law enforcement, while efforts to support a Quran recitation contest are also in progress. A volleyball tournament is planned for the national holiday, and a study tour to East Java is being arranged for local government officials to expand their knowledge. Additionally, infrastructure improvements are being made at a secondary school, and an integrated health post is being set up to offer regular medical services to resident.

Description of the Ecological conditions of the concession

PT Nusa Prima Manunggal operates within an area characterized by freshwater swamp forest and lowland rainforest in Sumatra, including a peat swamp region within the KHG Sungai Gongan - Sungai Nilo. The company has conducted a comprehensive inventory and mapping of its peat ecosystem, as outlined in the Peat Ecosystem Characteristics document, and has developed a Peat Ecosystem Recovery Plan, which includes monitoring water levels to maintain hydrological balance and prevent the construction of new canals. As part of its commitment to sustainable forest management, PT Nusa Prima Manunggal adheres to best practices in the social, environmental, and economic fields, reflected in its Sustainable Forest Management Policy 2.0 and its commitment to the High Carbon Stock Approach (HCSA). The company has conducted carbon stock assessments and identified conservation areas such as high conservation value (HCV) and high carbon stock (HCS) regions.

To ensure ecological sustainability, PT Nusa Prima Manunggal monitors land cover using satellite imagery, drones, and fire towers, implements a Fire Management System, and follows strict Standard Operating Procedures (SOPs) for forest

protection, fire control, waste management, and pesticide use. The company has established a Natural Nursery for rehabilitating the peat ecosystem and enriching biodiversity in protected areas. Forest protection also includes a policy of zero burning and a dedicated Forest and Land Fire Control Brigade. Additionally, PT Nusa Prima Manunggal promotes biodiversity conservation, including the protection of protected and threatened species, through monitoring and wildlife protection efforts. The company has also developed buffer zones and conservation areas, such as a 610 Ha protected area, to preserve forest and water resources.

In alignment with Indonesia's FOLU Net Sink 2030 target, the Organization has conducted integrated biodiversity and connectivity studies in collaboration with the Ministry of Environment and Forestry, ensuring that forest management aligns with national and regional conservation priorities. The company monitors the diversity of flora and fauna in its operational areas and protects endangered species from exploitation. Furthermore, PT Nusa Prima Manunggal fosters sustainable land use practices by implementing a land clearing moratorium until necessary conservation assessments are completed. The company also engages with local communities on non-timber forest product utilization, ensuring sustainable use of resources like honey and fish for personal consumption, under clear agreements and regulations.

Results of the Public Consultation

Prior to conducting Recertification Audit on PT Nusa Prima Manunggal, PT Acube TIC International has made a public announcement and public consultation. Invitation to public consultation to stakeholders to obtain input as materials/consideration through the website www.ajaindonesia.com starting 3 December 2024. The stakeholders can provide input for audit considerations to PT Acube TIC International email. There is no input from stakeholders.

The audit team also collected information from the mass media about PT Nusa Prima Manunggal. The reported cases are considered as part of the PT Acube TIC International audit process.

The Organization has identified all the necessary requirements for this certification process, which consist of legal aspects which include compliance with international rules and regulations and conventions. A management system has been developed to cover all activities in the area of certification, which are registered for the certification area of 4,289.00 hectares.

Organization progress record related to corrective action on findings of nonconformities in previous audit

The result of Transition to IFCC ST 1001:2021 + Surveillance 2 Audit were five (5) minor non-conformities. The Organization has made improvements and the non-conformities are closed.
