Brief Description of the concession

PT. Bumi Mekar Hijau received a Business License for the Utilization of Timber Forest Products in Plantation Forests based on Minister of Forestry Decree No. SK.338 / Menhut-II / 2004, dated 7 September 2004 concerning the Granting of IUPHHK-HTI to PT. Bumi Mekar Hijau over a Forest Area covering ± 127,870 Ha in South Sumatra Province.

In the same year, precisely on October 19, 2004, issued Minister of Forestry Decree No. SK.417 / Menhut-II / 2004 concerning Amendments to the Decree of the Minister of Forestry No. SK.338 / Menhut-II / 2004, dated 7 September 2004 concerning the Granting of IUPHHK-HTI to PT. Bumi Mekar Hijau over a Forest Area covering \pm 127,870 ha in South Sumatra Province. Based on this decision the concession area of PT. Bumi Mekar Hijau becomes \pm 250,370.

The boundaries of the concession area have been compromised with a length of 328,631,36 meters in Unit I and II, and along of 211,427.88 meters in Unit III. The boundary layout report is contained in TBT Report No. 08 / BPKH II.2 / 2013 2013 and TBT Report No. 22 / BPKH II.2 / 2014 of 2014. By this, issued the Minister of Environment and Forestry Decree No. SK.516 / MenIhk / Setjen / PLA.2 / 9/2017 dated 28 September 2017 concerning the Establishment of IUPHHK-HTI working areas of PT. Bumi Mekar Hijau Unit I of 125,615.86 hectares, Unit II of 70,163.98 hectares and Unit III of 57,813.19 hectares in Ogan Komering Ilir Regency, South Sumatra Province.

But then on November 28, 2018 the Minister of Environment and Forestry issued Decree No. SK.521 / Menlhk / Setjen / PLA.0 / 11/2018 concerning Second Amendment to Minister of Forestry Decree No. SK.338 / Menhut-II / 2004 dated September 7, 2004 concerning the granting of IUPHHK-HTI to PT. Bumi Mekar Hijau over a Forest Area covering ± 127,870 Ha in South Sumatra Province.

SK.521 / Menlhk / Setjen / PLA.0 / 11/2018 amended the first *Amar* No. 1 in SK.417 / Menhut-II / 2004 to: 1. The area of IUPHHK-HTI PT. Bumi Mekar Hijau becomes an area of \pm 249,650 ha, as the map attaches to this Decree. SK.521 / Menlhk / Setjen / PLA.0 / 11/2018 also added the provision of letter c to *Amar* Fourth A in SK.417 / Menhut-II / 2004 to, c. The Permanent Production Forest Area covering \pm 2,616 ha and Other Use Area (APL) of \pm 1,327 ha issued from the work area were handed over to the Regional Government and subsequently allocated to the local community through the TORA or Social Forestry scheme.

Administratively the concession area is located in Tulung Selapan, Cengal, Air Sugihan, and Sungai Menang Districts, Ogan Komering Ilir Regency, South Sumatra Province. Geographically, the Unit I is located at coordinates 02° 50' to 03° 18' South and 105° 13' to 105° 45' East, Unit II at coordinates 03° 15' to 03° 38' South and 105° 31' to 105° 48' East, and Unit III at coordinates 03° 54' South and 105° 21' to 105° 54' East.

PT Bumi Mekar Hijau divides the work area into 8 districts, namely: 1) Sungai Beyuku District, 2) Sungai Penyabungan District, 3) Padang Sugihan District, 4) Simpang Tiga District, 5) Sungai Ketupak District, 6). Sungai Serdang District, 7) Sungai Gebang District, and 8) Sungai Menang District.

This recertification audit visited 3 districts, namely Sungai Beyuku District, Sungai Penyabungan District, and Padang Sugihan District.

The management plan, namely RKUPHHK-HTI Year 2017 - 2026, has been approved based on MenLHK Decree No. SK.5029 / MenLHK-PHPL / UHP / HPL.1 / 9/2017 dated 29 September 2017 concerning the Approval of RKUPHHK-HTI Year 2017 - 2026 in the Framework of Improving Peat Governance on behalf of PT. Bumi Mekar Hijau in South Sumatra Province. There was an Adjustment of Business Plan for Utilization of Timber Forest Products in Industrial Plantation Forests (RKUPHHK-HTI) Period 2017 - 2026 Year Activity 2018 to 2019, which approved based on Decree of Minister of Forestry No. SK.2384 / MenLHK-PHPL / UHP / HPL.1 / 4/2018 dated April 25, 2018.

Furthermore, the Peat Ecosystem Recovery Plan has also been approved by the Director General of Pollution and Environmental Damage Control, Ministry of Environment and Forestry based on Letter No. SK.3 / PPKL / PKG / PKL.0 / 1/2018 dated January 2, 2018 concerning Peat Ecosystem Restoration Plan and Determination of Manual Groundwater Height Adjustment Points, Installation Points for Automatic Groundwater Height Measuring Devices, and Rainfall

Monitoring Station Points PT. Bumi Mekar Hijau.

At the time of the recertification audit, the management plan used was the Revised RKUPHHK-HTI Year 2017 - 2026, approved based on Decree of the Minister of Environment and Forestry No. SK.6047 / MenLHK-PHPL / UHP / HPL.1 / 6/2019 dated June 28, 2019 concerning Approval of Revision of RKUPHHK-HTI for 10 Years in the Period of 2017 - 2026 on behalf of PT. Bumi Mekar Hijau in South Sumatra Province.

PT. Bumi Mekar Hijau did not convert natural forest to plantations above December 31, 2010. Thus the area included in the scope of certification was 249,650 ha, including 37,849 ha (15.16%) of Local Protected Area and Other Protected Area, 160,143 ha (64.15%) of Staple Plant and 51,658 ha (20.69%) of Livelihood Plants.

The concession area has a B-type (Schmidt & ferguson) with a rainfall of 371 mm and a low of 63 mm. The soil type consists of Organosol, Podsolik, and Aluvial types. Its geological formations comprise the Kasai Formation, Aluvium, Swamp Deposits Formations. The cultivated crops are *Acacia crassicarpa, Acacia mangium*, and *Eucallyptus pelita*.

Description of the socio-economic conditions of the concession and the concession's social programs

The community lives in the concession is currently working for the Management Unit and the OKI Mill factory, while outside the concession there are villages that occupied by local community and the migrants.

There are indigenous groups that have lived in the concession for decades before the concession permit arrived. They formed a settlement in the concession area of PT Bumi Mekar Hijau which bordered with a Wildlife Reserve managed by BKSDA of South Sumatra.

The communities are mostly farmers who manage their plantations in the form of oil palm and fruit cultivation, and a few of the community work as rice farmers. The rest are fishermen, employee of forestry companies, and mining companies. The large distance between settlements and the concession caused the interaction between the community and PT Bumi Mekar Hijau is less intensive. There are only a few old hamlets within the concession that have high interactions with companies regarding regional interests, access in and out, and also the area of **the community's** livelihood cultivation.

There is a dispute in the concession, such as: the communities have been present in the area to clear land so that there is a dispute in the area adjacent to the community settlement area. Based on information from the board of Desa Makmur Peduli Api (DMPA), in 2015 the community had already surrendered their traditional land to an area of industrial forest plantations which would later become the area where permits were now given to PT Bumi Mekar Hijau. But at the time of the recertification audit, there were demands for the company to return the given land from the community. This is what caused the conflict between the company and the villagers because almost 30 percent of the village area around the village is close to the concession area of PT Bumi Mekar Hijau. PT. Bumi Mekar Hijau had handled the disputes with the community and the parties refer to the provisions of the community who want to use non-timber forest products with the procedure concerning Land Conflict Resolution.

There is an agreement between the management of PT Bumi Mekar Hijau and the surrounding village community as outlined in a formal legal document that allows the land utilization in the permit area and cooperative business, as follows:

- 1. The rights and obligations of each party are set forth clearly, as the company's responsibility and commitment to forest management rights that existed before the business permit was issued.
- 2. PT Bumi Mekar Hijau has made an agreement with the surrounding village community in the form of an MoU of Fire Aware Community (MPA), DMPA, Livelihood Plant, Utilization of NTFP.

PT Bumi Mekar Hijau have procedures on the Community Social Survey, Publication and Report of Community Deveopment (CD) Activity dated July 16, 2016. This procedure governs the determination of programs, budgets,

socialization and reporting of CD activities, person in charge of activities and activity reporting.

Before making the CD program, the management unit had collected information from the community through a village consultation meeting and an inventory of village potential data as a basis for attending village development planning meetings. In the RKT 2019 includes the establishment of Village-Owned Enterprises (BUMDes), agricultural counseling in collaboration with the Department of Agriculture, establishing acacia as species for livelihood plant partnerships (HTPK), developing food crop types (maize, rice), livelihood plants with social patterns (with patterns agroforestry), development of clean water facilities, access to public health services to the District P3K Posts.

Description of the Ecological conditions of the concession

Based on the Decree of the Minister of Environment and Forestry No. 2384 / MenLHK-PHPL / UHP / HPL.1 / 4/2018, concerning Approval of Adjustment of IUPHHK-HTI RKU, period 2017-2026, on behalf of PT Bumi Mekar Hijau in South Sumatra Province, the Management Unit had created an Industrial Plantation Forest spatial planning. For the Protected Area, the spatial is divided to River Border area of 7,787 ha (3.12%), KPPN of 470 ha (0.19%), KPSL of 22.721 ha (9.10%), Buffer Zone area of 1,001 ha (0.40%), and Peat Dome area of 5,870 ha (2.35%).

PT Bumi Mekar Hijau has a Manual for Sustainable Management of Plantation Forests, such as:

- Making micro planning maps before logging by making a skidding track plan
- Selection of heavy vehicles types in extraction with an 11 ton excavator (PC 100)
- Land preparation with spreading to maintain soil moisture
- Implementation of feeling coupe as a reference extraction path
- Determination of the location of landings in work plots
- Measure the width of the track not to exceed 4 meters
- Only cut down tree yields (TPO), natural trees are abandoned
- Loosening with Spot Cultivator
- Making tertiary trenches and collectors functioned as water management o avoid flooded areas.

PT Bumi Mekar Hijau has identified areas that function to protect water, for example borders of rivers and lakes, wetlands, drinking water sources, coastal forests, with these activities:

- Make a map of peat depth, Determination of Groundwater Surface Height Arrangement Points, Installation Points for automatic groundwater level measurements and rainfall monitoring station points, allocate a Germplasm Conservation Area (KPPN) covering an area of 470 ha located in the peat ecosystem protection function. This KPPN has a high level of species diversity. The dominant is mostly in the form of poles and saplings, with a few trees with a diameter of 30 cm. The Management Unit needs to enrich local species so it can support the area function.
- Create a Protected Buffer zone area of 1,047 ha which is a mangrove forest area bordering PT Bumi Mekar Hijau. This area is an ecotourism between mangrove and peat ecosystems. In addition, this protected area functions as: water conservatory, carbon storage, and habitat for protected and endemic aquatic animals.

PT Bumi Mekar Hijau has identified, inventoried protected, endemic, rare and threatened/endangered flora and fauna in the concession area. Flora's observations are based on vegetation analysis activities. While the observation of fauna is based on the wildlife monitoring activities.

PT Bumi Mekar Hijau has identified and monitored the disruption of sustainable forest management activities. These activities are listed in the AMDAL documents, RKUPHHK, HCV Assessment Report and Conflict Mapping Report. These activities include the prevention of pests and diseases, inventory and mapping of protected, rare, endangered, sensitive forest ecosystems or ecosystem representations, such as riparian areas and wetland biotopes, the genetic resources of local native species (and their derivatives) that are threatened or protected. Illegal logging activities do not exist because the potential of large trees is difficult to find. River Border does not have large trees because it has been

encroached on by communities around the forest to become rubber or oil palm plantations. Other types of forest disturbance such as illegal mining and poaching are also not found in the concession area. Plant pests and diseases are rare and do not have a significant impact on production. Weed eradication is carried out by periodic spraying with the type of herbicide permitted in this Standard.

In addition to being identified, the Management Unit regularly monitors the disturbances to find out about the disruption of the through patrol activities and reports. The monthly patrol report is also recapitulated into the Environmental Permit (Environmental Management and Monitoring) Implementation Report every semester.

Results of the Public Consultation

Before conducting the Recertification Audit, PT AJA Sertifikasi Indonesia conducted a public consultation starting November 6, 2019, asking stakeholders to provide feedback and information about PT Bumi Mekar Hijau. The public consultation is uploaded to the PT AJA Sertifikasi Indonesia website (<u>www.ajaindonesia.com</u>), sent to parties via e-mail or postal mail, and published in local newspapers.

There were response from a village government stakeholder which stated that PT Bumi Mekar Hijau has conducted the MoU realization between the company and the village, in the aspect of forest resources utilization in the concession area, CD-CSR program, and agricultural aspect to develop the community welfare.

The audit team also collected information from the mass media about PT Bumi Mekar Hijau. The reported cases are considered as part of the PT AJA Sertifikasi Indonesia audit process.

The Management Unit has identified all the requirements needed for this certification process, which consists of legal aspects which include compliance with rules and regulations and international conventions. The management system has been established to cover all activities in the field of certification, which are registered for certification of 249,650 hectares.

Findings on the certified client conformity with the certification requirements and description of critical issues in relation to the conformity.

Based on the results of the Recertification Audit of PT Bumi Mekar Hijau, there are 4 (four) Non-Conformities of Minor nature were identified by the audit team.
