

All of the area PT. Bukit Raya Mudisa is mineral land with primary plants *Acacia mangium*. For management and monitoring environment PT. Bukit Raya Mudisa has manages the ecosystem and hydrology, biodiversity management , and protected forest.

PT. Bukit Raya Mudisa has monitored and managed environment like: Standard Operating Procedures (SOP) environment management, indigenous plants, Reduced Impact Logging (RIL), erosion and sedimentation monitoring, socialization protected area for local people Durian Simpai, Nagari Koto Nan IV Dibauah, Sub district IX Koto, district Dharmasraya, forest fire monitoring, domestic waste management separated organic dan non organic, and bio hazardous monitoring.

PT. Bukit Raya Mudisa give respect for local people rights (culture) and indigenous land as sett in local government regulation West Sumatra number: 6 years 2008 about Indigenous land and Useful.

In Areal PT. BRM does not have permission from Ministry of Forestry managed Non Timber Forest product/NTFP (gum, bark, seedling, leaf, rattan or bamboo).

Local people around PT. Bukit Raya Mudisa uses NTFP as honey seekers. PT. Bukit Raya Mudisa has managed for local people that seek the honey every 3 months. PT. Bukit Raya Mudisa has data for it.

PT. Bukit Raya Mudisa has good communication with local people. PT. Bukit Raya Mudisa has tried to full fill Workers right based on company regulation number : 560/122/SK-PP/Sosnakertrans/III/2014, dated 17 Maret 2014.

PT. Bukit Raya Mudisa has identified healthy risk and safety worker (HIRADC). PT. Bukit Raya Mudisa has plan program for Safety and health in 2015 (OHS Objective and Management Program 2015). The area that has high potential dangerous is : Gas station, waste management, Camp construction, generator electrics and camp installation.

Findings on the certified client certified client conformity with the certification requirements and description of critical issues in relation with the conformity.

PT. Bukit Raya Mudisa has Non Conformity (NC) : 1 major, 7 Minor dan 20 observation. All of NC has made Corrective Action Required (CAR) for indicate seriously and commitment in order sustainable forest management and continuously improvement for increasing the performance.

The nonconformities findings are company profile that has not fulfilled about total production, best management practices for forest plantation, and manpower; standards for permanent sampling plot labeling and monitoring; no facility for hand and eye washing at Bio hazardous building; illegal logging and encroachment forest at block 753; wood fee for Kenagarian Lubuk Ulang Aling South Solok district; The aids for repairing main road on kampong length 10 km Kenagarian Lubuk Ulang Aling South Solok district; no instrument light fire extinguisher (APAR) at barrack 60 contractor camp.

PT. Bukit Raya Mudisa in performing sustainable forest management IFCC standard has strived to be able to meet all the requirements in the standard IFCC ST 1001: 2014. Some of the main issues that arise are related to environmental management by the land forest fire disasters and social issues related wood fee and corporate social responsibility program length 10 km.

Related to this things, PT. Bukit Raya Mudisa has undertaken several action by monitoring of forest fire danger by cooperate with local governments and local communities.

Bukit Raya Mudisa has made documentation fee nagari Lubuk Ulang Aling that has implemented; PT. Bukit Raya Mudisa has made documentation about main road repair length ± 12 km that signed by Chief/Head *Kanagarian_Kampung Baru* dated September 9th 2011; PT.
